The Department of Collegiate Education has initiated Automation of Libraries of Govt. Degree Colleges in the State in phased manner in association with UGC-INFLIBNET. In this connection a five day training program for the Librarians of 50 Govt. Degree Colleges was organised at Hyderabad from 04.12.2006 to 08.12.2006 vide ref(1)&(2) cited above.

The Librarians of 50 selected Govt. Degree Colleges (Annexure-I) were trained to install and operate the 'SOUL' software. The directorate of collegiate education has purchased SOUL software from INFLIBNET Centre and each college of these 50 colleges were supplied with the original copy of CD containing 'SOUL' software, hardware lock and users manual. The original software CD was handed over to the Librarian at the training centre and the same has to be entered in to the stock register of the Library and proper entries shall be made in the college records. The Principal should see that the software CD must be kept under the control of the College Librarian and it shall be used for automation of the college Library. The Principal/Librarian is held responsible for any loss of SOUL software CD and hardware lock which was supplied by Directorate of Collegiate Education(The total cost of the SOUL software is Rs. 20,000/-).

As per the ref(2) cited above, the Director of Collegiate Education has accorded sanction of expenditure from the spl.fee/restructured spl.fee of Rs. 1.00 Lakh for purchase of computer hardware for Library automation. The Principal is directed to take a resolution for Rs. 1.00 Lakh as per the proceedings of the DCE and send a letter to the Director of Collegiate Education for e-procurement of required computer hardware immediately.

In the mean while the Principal is hereby instructed to take the following steps immediately to start up the library automation activity at the college.

- 1. Shift one computer system from the existing computer lab (which is recently purchased) to College Library to start the automation activity. The system must be of the following configuration: P4 with CD drive. This system shall be shifted temporarily until new systems are provided to the Library.
- 2. The SOUL software installation teams will reach the college within one week and a schedule is enclosed in **Annexure-II** for reference.
- 3. The Principal shall take all steps to immediately to install and operationalize the 'SOUL' Software in the college library.
- 4. The Principal shall provide the required hardware and other facilities in the library.
- 5. If needed, the initial support of the services of the Computers Faculty etc. can be taken from the existing Computer faculty.
- 6. The principal is also permitted to engage a computer programmer/operator for data entry and installation support from time to time in the library on hourly basis and the remuneration shall be met from restructured courses special fee/spl. Fee of the college. The librarian must be supported by one computer operator all the way and the process/support shall continue throughout the year.
- 7. The Principal shall also ensure entry of library records etc. into the 'SOUL' system and proper encouragement to staff and students to use the facility.
- 8. The Principal shall see that the automation of the Library must be completed on or before 31.03.2007.
- 9. The Principals shall send the report on above points immediately on receipt of these proceedings in the name cover of Dr R David Kumar, Chief Information Officer, O/o Director of Collegiate Education, A.P., Nampally, Hyderabad.

The Principal should bestow his/her personal attention on the matter and complete the task without loss of time, as the Library Automation activity in Govt. Colleges in the state is a prestigious programme of the Directorate of Collegiate Education. Any lapses or deviation on the matter will be viewed seriously.




